



Entering CMSS during Phase 2

Guidelines for entering CMSS during Phase 2

- In order to keep our community safe and healthy, all students, parents, and caregivers entering our buildings are required to read and sign our COVID-19 Liability Waiver. Faculty and staff must sign the COVID-19 Safety Agreement.
- Entry into CMSS is by appointment only.
- Our community shares respect for one another by wearing a face covering at all times. Masks are required for all individuals over the age of 2, per CDC Guidelines. **Masks must cover both the mouth and nose at all times.**
- **Prior to coming to CMSS, all students, families, faculty and staff are required to monitor for symptoms of COVID-19.** If you have been symptom-free for the 72 hours prior to your programming or visit, you may come to CMSS, following mask protocol. If you have any symptoms, STAY HOME and contact your doctor. Symptoms of COVID-19 are as follows:
 - Fever (100.4 or higher), chills, or shaking chills
 - Cough (not due to other known cause)
 - Difficulty breathing or shortness of breath
 - New loss of taste or smell
 - Sore throat
 - Muscle aches or body aches
 - Nausea, vomiting, or diarrhea
 - Headache, when in combination with other symptoms
 - Fatigue, when in combination with other symptoms
 - Nasal congestion or runny nose (not due to other known causes, such as allergies) when in combination with other symptoms
- When you arrive at the building, you will be asked a series of questions attesting to your health and CMSS policies prior to being buzzed in. These questions may be found in the CMSS COVID-19 Attestation document.
- All faculty, staff, and visitors entering the building must sign in on the Building Access Log.
- All individuals are required to wash or sanitize hands upon entry to CMSS.
 - Hand sanitizer will be available in common areas.
- Please practice social distancing (6 feet) when moving around CMSS. If able, you are encouraged to use the stairs and not the elevators.

- Non-essential visitors are welcome to wait in their vehicles or outside of CMSS, as our reception area is closed. Essential visitors are defined as parents/caretakers of students, vendors and contractors whose services are required for CMSS functioning (HVAC workers, security guards, etc.), and Emergency Services Personnel (police, fire, ems, etc.).
- Students under age 18 must be accompanied by a parent/caregiver at all times, including in the studio space while taking their lesson (exception: students 16+ and their parent/guardian may sign the Student/Guardian Responsibility Agreement for Lessons waiver or the Student/Guardian Responsibility Agreement for Studio Space waiver if they wish to be at CMSS without a parent/caregiver).
- Communal toys, magazines, tangible items, and books have been temporarily removed for the safety of our community.
- Students, parents, and caregivers are asked to refrain from eating or drinking onsite unless necessary for a health condition.
- Although our restrooms are available for use, it is recommended that you try to plan to not use the CMSS restrooms if possible. Faculty should use the locked faculty restroom on the 2nd floor. Students should use the restroom on the same floor they're taking their lesson. Wipes and gloves are available in all restrooms with posters recommending that commonly touched surfaces get wiped after using the restroom, but before washing hands.
